1 Briefly describe the organization's mission: To explore and care for the ocean by advancing public awareness of the ocean's importance as Earth's life support system, fostering new technologies, furthering scientific knowledge of ocean systems by igniting public support for a network of marine protected areas--Hope Spots--large enough to save and restore the ocean.

4a (Code:) (Expenses \$ 532,382 including grants of \$) (Revenue \$ 252,182) Outreach & Education: The Mission Blue online ocean community has grown to approximately 35 million social media impressions per month and our biweekly newsletters boast over 40,000 subscribers. In 2014, Mission Blue was granted consultative status with the Economic and Social Council of the United Nations. Our Netflix documentary, Mission Blue, received a News & Documentaries Emmy Award, bringing increased awareness of Dr. Earle's work to millions of families around the globe. Netflix provides its services to 70 million subscribers in over 190 countries.

4b (Code:) (Expenses \$ 143,417 including grants of \$) (Revenue \$ 170,612) Expeditions: A cornerstone of Mission Blue is the expeditions program. Dr. Earle and the Mission Blue team travel to Hope Spots to explore, create awareness, foster partnerships, and build public and governmental support for the creation of marine protected areas. In 2016, expeditions included the Gulf of California, where we urged Mexican officials to create more MPAs and to reduce the number of shark fin exports. Working with community leaders and scientists, we also organized public forums, presentations, and a snorkeling adventure with the children of Cabo Pulmo. During the Mission Blue II expedition to Papua New Guinea and the Solomon Islands, we ignited support for protection of the Coral Triangle Hope Spot aboard the National Geographic Explorer. During the fall, we explored the Balearic Islands where we continued our efforts to support Mission Blue's first Hope Spot in the Mediterranean.

4c (Code:) (Expenses \$ 248,013 including grants of \$) (Revenue \$ 130,000) Hope Spot Global Framework: With more than 300 official Hope Spot nominations submitted through our website to date and a partnership with IUCN, SEA is in the process of standardizing Hope Spot designations and creating an online management system that will guide communities and partners through the process of managing these potential marine protected areas. A Hope Spot Advisory Council has been established to maintain oversight for the development of criteria and methodology for Hope Spots and oversees approved processes and criteria for global nominations.

General Information

In general, for taxable years beginning on or after January 1, 2015, California law conforms to the Internal Revenue Code (IRC) as of January 1, 2015. However, there are continuing differences between California and federal law.

A Purpose

Use form FTB 3885F, Depreciation and Amortization, to compute depreciation and amortization allowed as a deduction on Form 541, California Fiduciary Income Tax Return, Form 109, California Exempt Organization Business Income Tax Return, or Form 199, California Exempt Organization Annual Information Return.

Depreciation is the annual deduction allowed to recover the cost or other basis of business or income producing property with a determinable useful life of more than one year. Land is not depreciable.

Amortization is an amount deducted to recover the cost of certain capital expenses over a fixed period.

B Federal/State Differences

California law has not always conformed to federal law regarding depreciation methods, special credits, or accelerated write-offs. Consequently, the recovery periods and the basis on which the depreciation is calculated may be different from the amounts used for federal purposes.

- Before January 1, 1987. California disallowed depreciation under the federal Accelerated Cost Recovery System (ACRS).
On or after January 1, 1987. California provides special credits and accelerated write-offs that affect the California basis for qualifying assets.
On or after September 11, 2001. California has not conformed to the federal Job Creation and Worker Assistance Act of 2002 which allows taxpayers to take an additional first year depreciation deduction and Alternative Minimum Tax depreciation adjustment for property placed in service after September 10, 2001.
Amortization of Certain Intangibles. California conforms to IRC Section 197 relating to the amortization of intangibles as of January 1, 1994.
American Recovery and Reinvestment Act of 2009. California does not conform to the additional 50% first year special depreciation for qualified property acquired and placed in service on or after December 31, 2007.

- Election to Expense Certain Tangible Property. (IRC 179) This election does not apply to estates and trusts.

Differences may also occur for other less common reasons. This list is not intended to be all-inclusive of the federal and state differences. For more information about adjustments, get FTB Pub. 1001, or refer to the R&TC.
